- electronic bids must be submitted to the office Dhunibeshi Municipality, Dhading through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 on 2080/01/05. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on 2080/01/05 at the office of Dhunibeshi Municipality, Dhading. Bids must be valid for a period of 120 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs as explain below., which shall be valid for 30 days beyond the validity period of the bid.
