- Dhunibeshi Municipality, office of the Municipal Executive has allocated funds towards the cost of Construction of Office Building of Dhunibeshi Municipality and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Office Building of Dhunibeshi Municipality. Bidding is open to all eligible Nepalese Bidders.
- 2. Dhunibeshi Municipality invites electronic bids from eligible bidders for the construction of Office Building of Dhunibeshi Municipality under National Competitive Bidding- Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding: Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 9,55,00,000.00 (Excluding VAT)
 - Minimum Work experience of similar size and nature: Two Building Contracts with single basement within
 the last ten (10) years, each with a value of at least NRs10,18,00,000.00 (Excluding VAT) that have been
 successfully or are substantially completed with complete single package of structure, finishing and MEP
 works and that are similar to the proposed works. The similarity shall be based on the physical size,
 complexity, methods, technology or other characteristics as described in Section VI, Works Requirements.
- 3. Eligible Bidders may obtain further information and inspect the Bidding Documents from PPMO's e-procurement system www.bolpatra.gov.np/egp
- 4. Bidders shall download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit non-refundable cost of Nrs.10,000.00 (In words: Ten Thousands rupees only) for bidding document in the Project's Rajaswa (revenue) account as specified below. - Pre-bid meeting shall be held at Office of Dhunibeshi Municipality, Dhading at 11.00 AM of 21st (2077-3-25) from the date of publication of notice.
- 6. Electronic bids must be submitted through from PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12.00 noon 31st day of publication of the notice (2077-4-4). Bids received after this deadline will be rejected.
- 7. The bidders are strongly encouraged to visit the site before bidding.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2.00PM at 31st day of bid publication notice (2077-4-4) at the Office of Municipal Executive of Dhunibeshi Municipality, Address: Khanikhola, Dhading. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security amount of Nrs.3,200,000.00, on Account No. 10300303000003 Dharauti Khata No. which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
